## FAIRMONT RESORT & SPA CANCELLATION & ATTRITION FEES

## Cancellation of functions will attract fees calculated as follows:

- (a) Cancellation outside of sixty-one (61) days of the function the paid security deposit will be forfeited only.
- (b) Cancellation within sixty (60) days 50% of the Estimated Function Charge.
- (c) Cancellation within thirty (30) days 100% of the Estimated Function Charge.

## Cancellation or Attrition of Accommodation Rooms will attract fees calculated as follows:

If you cancel your accommodation booking:

- (a) More than ninety (90) days before the first contracted arrival the Hotel shall release all rooms without charge.
- (b) Between thirty (30) and ninety (90) days before the first contracted arrival you will be required to pay 50% of the estimated accommodation charge for all room nights cancelled.
- (c) Within thirty (30) days and fourteen (14) days, 75% of the estimated accommodation charge for all room nights cancelled.
- (d) Within fourteen (14) days, 100% of the estimated accommodation charge for all room nights cancelled.

If you reduce your accommodation room nights (Attrition):

- (a) More than ninety (90) days before the first contracted arrival up to 30% of your total accommodation room nights may be released without charge. If more than 30% of the total accommodation room nights are released the Hotel reserves the right to renegotiate your contracted room rates.
- (b) Between thirty (30) and ninety (90) days before the first contracted arrival up to 20% of the total accommodation room nights may be released without charge. If more than 20% of the total accommodation rooms nights are released you will be required to pay for 50% of the contracted rate for each room night released above the 20% threshold.
- (c) Within thirty (30) and fourteen (14) days before the first contracted arrival up to 10% of the total accommodation room nights may be released without charge. If more than 10% of the total accommodation room nights are released you will be required to pay for 50% of the contracted rate for each room night released above the 10% threshold.
- (d) Within 14 of arrival, any cancellations, release of rooms or 'no shows' will be charged 100% of the total accommodation charge.
